The 2018 Peninsula Flea at Heritage Farms is an upscale flea market, featuring handmade, repurposed and vintage items. Heritage Farms strives to offer high quality items from dedicated artists, crafts people and collectors. This is not your grandmother's flea market.

Heritage Farms is a 170 year old 5th generation family owned farm located in Peninsula at 6050 Riverview Road. The PENINSULA FLEA will be held on the first Saturday of each month from June to September plus a second market in June. Market dates will be JUNE 2nd, JUNE 30th, JULY 7th, AUGUST 4th, and SEPTEMBER 1st 2018. Market hours are 10:00am to 4:00pm.

Outdoor lawn spaces will be available to rent. Vendors will be responsible for providing their own 10'x10' awning or tent and their own display, tables, chairs etc. There is no electrical hook up available. Indoor spaces are available in the historic Farm Barn and in the Tree Barn. Indoor spaces are 8'x8' and are the same prices as the outdoor spaces. No vehicles will be allowed in the vendor area after set up. Separate parking will be provided for all vendors behind the Tree Barn in the upper lot.

Direct sales and mass- produced items are not permitted. All vendors must present a professional looking display, with no visible piles of excess boxes and bins. These items must be returned to your vehicle or hidden under your skirted tables. All items must be clearly priced.

Rental fees:

\$40.00 for a 10'x10' space or indoor 8'x8' space
\$75.00 for a 10'x20' space. No double space is available in either barn.

Additional Fees: ____\$2.00 Paypal fee ____ \$5.00 late fee

Space rental, paid in advance for all 5 markets will receive a 10% discount.

ONCE YOU ARE ACCEPTED AS A VENDOR: Your fee MUST be paid in full NO LESS than 14 days prior to the date of the Flea(s) you are participating in. There will be a \$5.00 surcharge for any payments made after the 14 day payment date. In order to receive the 5 market 10% discount, you must pay in full for all 5 markets no later than April 30, 2018.

Paypal is available with a \$2.00 fee to cover the fee charged by Paypal – Please send to carolbishopharamis16@gmail.com. THIS ADDRESS IS FOR PAYPAL PAYMENT ONLY.

We only accept checks, cash or Paypal. No credit card payments available.

This is a rain or shine market. Fees will not be returned or credited if you do not attend.

We are pleased to offer spacious grounds with a beautiful farm setting. Our parking is free for both vendors and customers. Vendors are able to unload and load within 50' of your site. We also offer carts and Heritage Farms staff to help. Friday night tent and table set up is available by prior arrangement with Carol. Clean porta johns are located close to the flea market site.

Set up is the day of the event. Vendors may arrive no earlier than 7:00am and must be completely set up and ready to sell by the 10:00am opening. Tear Down is not to begin until after the market closes at 4:00pm and must be completed by 5:30pm. Vendors are responsible for tear down and disposing of all trash from your space.
